



BIRCH HILLS COUNTY

BYLAW NO. 05-08

BEING A BYLAW PROVING FOR THE CLOSURE AND LEASE OF ALL OR A PORTION OF A CERTAIN PUBLIC HIGHWAY WITHIN THE TERRITORIAL LIMITS OF BIRCH HILLS COUNTY IN THE PROVINCE OF ALBERTA.

WHEREAS, Section 22 of the Municipal Government Act Chapter M-26, RSA 2000 and amendments thereto, provide that the Council of Birch Hills County may with the approval of the Minister of Transportation, pass bylaws for the purpose of closing the whole or any portion of any road;

AND WHEREAS the lands herein described are no longer required for public travel and the Council for Birch Hills County considers it necessary to close and lease the public highway described herein and shown on Schedule "A", which schedule is attached to and forms part of this Bylaw;


AND WHEREAS notice of the County's intention to close and lease the public highway described herein has been published in the local newspaper, on June 17, 2008 and June 24, 2008 the last date of publication being at least fourteen (14) days before the date fixed for the passing of this Bylaw;

AND WHEREAS Council provided the opportunity for any person prejudicially affected by the bylaw to be heard and recorded at a Public Hearing held on August 13, 2008.

NOW THEREFORE be it resolved that the Council for Birch Hills County, duly assembled does hereby close to public travel and lease the public highway described as follows and shown in Schedule "A", which schedule is attached and forms part of this Bylaw, subject to the rights of access granted by other legislation.

1. Subject to the approval of the Minister of Transportation, all that portion of road allowance that borders:
 - the South East and South West Quarters of Section Sixteen (16), Township Eighty (80), Range Twenty Four (24), West of the Fifth (5) Meridian;
 - The North East and North West Quarters of Section Nine (9), Township Eighty (80), Range Twenty Four (24), West of the Fifth (5) Meridian.
2. This Bylaw shall come into effect upon the date of the third and final reading.
