TANGENT CIVIC ADDRESSES

BYLAW NO. 2013-08

A BYLAW OF BIRCH HILLS COUNTY IN THE PROVINCE OF ALBERTA REQUIRING THE NUMBERING OF STREETS, AVENUES, AND HOUSES WITHIN THE HAMLET OF TANGENT.

WHEREAS, it is expedient for Birch Hills County to pass a Bylaw requiring the numbering of Streets, Avenues, and Houses in the Hamlet of Tangent;

NOW THEREFORE THE COUNCIL OF BIRCH HILLS COUNTY DULY ASSEMBLED, ENACTS AS FOLLOWS:

- 1) **THAT** Streets West of Hwy 740 (9th STREET) shall be numbered up consecutively and Streets East of Hwy 740 (9th STREET) shall be numbered down consecutively according to the Map, attached here to as Schedule "A" of the Bylaw.
- 2) **THAT** Avenues North of RAILWAY AVENUE shall hereinafter be numbered down consecutively and the Avenues South of RAILWAY AVENUE shall be numbered up consecutively according to Map, attached hereto as Schedule "A" of the Bylaw.
- 3) **THAT** house numbering on Avenues shall commence at each Street intersection with numbers even on the North side of each Avenue and odd numbers on the South side of each Avenue, continue numbering upwards in a Westerly direction until the intersection of the next Street. The first digits of the property number shall indicate the Street from which the numbering commenced, the last two digits of the number of the house as arrived at from this system.
- 4) **THAT** house numbering on Streets shall commence at each Avenue intersection, and with even numbers on the West side of each Street and odd numbers on the East side of each Street continue numbering upwards in a Northerly direction until the intersection of the next Avenue. The first digits of the property number shall indicate the number of the Avenue from which numbering commenced, the last two digits being the number of the house as arrived from this system.
- 5) **THAT** number shall be assigned to each building site taking into consideration the size of the lots in that particular residential or business area.

- 6) **THAT** it shall be the duty of every property owner, at his/her own expense, to have property numbers shown on or near the front entrances. Said numbers shall be prominently displayed, and shall be at least 7.62 centimeters, (3 inches) in height and painted in a contrasting color that can be easily read from the Street or Avenue. It shall be the duty of all property owners to first ascertain the proper number by inquiring at the County Office.

- 7) **THAT** the County authorities shall as soon as practical, erect at each intersection, a post or posts showing Street and Avenue numbers.

- 8) **THAT** any person or persons violating the provisions of this Bylaw or not complying with the requirements as set out herein or any person destroying, tampering with, or changing any number or sign posts placed to comply with this Bylaw shall, on summary conviction before any Justice of the Peace or any Police Magistrate having jurisdiction in the Hamlet of Tangent, be liable to a penalty of not less than \$25.00 and not more than \$100.00. The above penalty will not be enforced until 60 days after the third and final reading of this Bylaw.
